Sir,

- While participating the program they will be treated as on duty.
- The official and Cadets will draw thier pay and allowances in local currency; no part of it shall be drawn in foreign currency.
- Only the expenses of air travel for the invitees to and from Nepal will be borne by the Government of Bangladesh and the expenses of their stay in Nepal will be met by the Nepal Government.
- They will not be allowed to stay abroad more than the period approved; and
- Team Leader will submit a report on their participation within 15 days after their return.


