Local transportation and hospitality for all the participants and expenses for roundtrip air ticket of economy class and local accommodation for Dr. Abdus Salam, Prinicpal Scientific Officer, SPARRSO will be borne by APSCO. In connection with the visit, all other expenses as per rules will be borne by the Govt. of Bangladesh. Expenses for roundtrip air ticket and local accommodation for Mr. Akhter Hussain Bhuiya, Secretary, Ministry of Defence will be borne by the Government of Bangladesh;
  - d. The delegation will submit a report within 15 days after their return;
  - e. Overstay will not be allowed.
